2. That the subject 8605 JV-P Byers Well No. 1 constitutes the discovery well for a new Wolfcamp gas reservoir.

3. That the existing West Osudo-Wolfcamp Oil Pool established by Division Order R-7858 entered April 1, 1985, should be contracted to delete the NE/4 of Section 23, T20S, R33E, NMPM.

4. That Special Pool rules, including a provision for 160-acre spacing should be established for a temporary period of 18 months in which to adequately develop data concerning this reservoir.

5. That the subject discovery well is adjacent to, but separated from, the Southeast Lea Wolfcamp Gas Pool created on July 1, 1986 by Division Order R-3438 thereby constituting a new and separate pool.

WHEREFORE, applicant requests that the Division set this matter for hearing and that after notice and hearing the application be granted as requested.


Dear Mr. Byers:







While the advertisement in the Examiner's docket shows the correct range, our prior notice to you dated January 26, 1987 incorrectly showed the range to be 33 East.


