NOMENCLATURE ADVERTISEMENT FOR MAY, 1987

In the matter of the application of the Oil Conservation Division of the Energy and Minerals Department upon its own motion for an order for the creation, contraction, and extensions of certain existing pools in Lea County, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to show cause why such creations, contractions, and extensions should not be made.

(a) CREATE a new pool in Lea County, New Mexico, classified as an oil pool for Bone Spring production and designated as the Gem-Bone Spring Pool. The discovery well is the Manzano Oil Corporation Federal 31-G Well No. 1 located in Unit H of Section 31, Township 19 South, Range 33 East, NMPM. Said pool would comprise:
