7                   Q            Would you please state your name, by whom  
8 you're employed and in what capacity?

9                   A            I'm Michael E. Stogner. I'm employed  
10 with the New Mexico Oil Conservation Commission and Division  
11 here in Santa Fe Office as a petroleum engineer.

12                  Q            Mr. Stogner, you've previously testified  
13 before the Commission or its Examiners and had your creden-  
14 tials accepted?

15                  A            Yes, I have.

16                                 MR. TAYLOR: Mr. Examiner, is  
17 the witness qualified?

18                                 MR. CATANACH: He is.

19                  Q            Mr. Stogner, are you prepared to make re-  
20 commendations to the Examiner today concerning the nomen-  
21 clature of certain pools in Eddy, Lea, and Roosevelt Coun-  
22 ties, New Mexico?

23                  A            Yes, I am.

24                  Q            Are your recommendations prepared in the  
25 form of an exhibit?

1           A           Yes, I have two separate exhibits for  
2 each case.

3           Q           And how are those Exhibits denominated?

4           A           Roman Numeral 1 for both.

5           Q           Okay, I in Case 9185 and I in Case 9186.

6           A           Yes, that's correct.

7           Q           Would you please first refer to your  
8 Exhibit I in Case 9185 and tell us if there's any  
9 differences between that exhibit and the information on the  
10 docket today that's been handed out?

11          A           Everything has been checked and there are  
12 no differences between the exhibit and the docket today.

13          Q           Okay, and would you refer to your Exhibit  
14 I in Case 9186 and tell us if there are any differences  
15 between that the docket which has been distributed.

16          A           That has also been checked and there are  
17 no differences there, either.

18          Q           Okay. Do you have anything further to  
19 add to your testimony?

20          A           I have nothing further.

21          Q           Was Exhibit I in Case 9185 and Exhibit I  
22 in Case 9186 prepared by you or under your supervision and  
23 control or have you examined the contents of the documents  
24 and assured yourself of their accuracy?

25          A           Yes, I have.

1 MR. TAYLOR: I'd move the  
2 admission of Exhibits One in Case 9185 and 9186.

3 MR. CATANACH: Exhibit I in  
4 Case 9185 and Exhibit I in 9186 will be admitted into  
5 evidence.

6 MR. TAYLOR: And that's all we  
7 have.

8 MR. CATANACH: Thank you, Mr.  
9 Stogner.

10 There being nothing further in  
11 Case 9185 and 9186, they will be taken under advisement.
