Gentlemen:

Sun Exploration and Production Company has approached your company several times in the past concerning the drilling of a Morrow wildcat in the subject prospect. Due to budget constraints, market economics or other conditions, the prospect was not drilled. Sun again would like to discuss drilling a Morrow test along the following terms and conditions:

- 1) The leasehold owners form a one-section working interest unit comprising all of Section 26-T18S-R33E, Lea County, N.M.. The initial location for a 13,700' Morrow test will be 1980' FNL and 1980' FEL. The unit will cover rights from 100 ft below the base of the Queen Sand down to 100 ft. below the base of the Morrow formation. The initial proration unit will cover the N/2 of Section 26.
- 2) All leasehold owners will have the right to participate in any unit wells for their proportionate interest. Anticipated costs for the initial well are \$820,000.00 for a dry hole and \$1,200,000.00 for a completion.
- 3) Any unit owner not desiring to participate will farmout to the unit. Farmout terms will deliver a 75% net revenue lease to the consenting owners with the option of converting the reserved overriding royalty to a 25% working interest at payout of the test well. Both the ORRI and reversionary working interest will be proportionately reduced as to your unit interest.
