Order No. R-8570 pooled all mineral interests in Lot 1, SE/4 NE/4, Section 4, Township 17 South, Range 37 East, N.M.P.M., Lea County, New Mexico, and authorized TXO Production Corp. to re-enter the abandoned Hightower No. 1 Well and to directionally drill and deepen the well to a standard bottom hole location for the Shipp-Strawn Pool.

The re-entry attempt has been unsuccessful because of mechanical problems. TXO Production Corp. proposes to move the rig, now on location, to a standard surface location under the Shipp-Strawn Pool Rules, in Lot 1 of said Section 4, and drill the well vertically to a standard bottom hole location under such rules on the same spacing unit previously approved.

The record will reflect that this contingency was anticipated and at the hearing held on October 7, 1987, the applicant presented evidence on the point and requested that the order permit the drilling of the well in the same manner as now proposed if the re-entry proved unsuccessful. Although TXO Production Corp. was

opposed at the hearing, no issue was raised on this point. The Order issued inadvertently did not address the requested procedure.

I believe the record adequately covers this eventuality, and that this would be an appropriate case for entry of a Nunc Pro Tunc Order authorizing the procedure now proposed. There will not be any prejudice to any third parties under this procedure. Since the rig is on location and time is of the essence, prompt consideration of this request by your office is greatly appreciated.
