- 1. Applicant is the operator of the S/2 of Section 23, Township 19 South, Range 25 East, N.M.P.M., Eddy County, New Mexico, and proposes to drill its Parino 23 K Well #2 at a point 1500 feet from the South and West lines of said Section 23 and to simultaneously dedicate the S/2 of Section 23 to this well and its Parino Well No. 1 located 1980 feet from the South line and 660 feet from the East line of said Section.
- 2. Applicant seeks an exception to the well location requirements of Oil Conservation Division Rule 104 to permit the drilling of the well at the above described unorthodox location to a depth sufficient to adequately test the Pennsylvanian formation, Boyd Morrow Field.

3. That approval of this application will afford applicant the opportunity to produce its just and equitable share of hydrocarbons underlying this spacing unit and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.
