
Re: Application of Nearburg Producing Company for Compulsory

This letter is to advise you that Nearburg Producing Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of all mineral interests to the base of the Strawn formation, in and under the N/2 SW/4 of Section 1, Township 17 South, Range 37 East, N.M.P.M., Lea County, New Mexico. Nearburg Producing Company proposes to dedicate the referenced pooled unit to its Price Family #1 Well to be drilled 660 feet from the West line and 2130 feet from the South line of said Section 1.

This application has been set for hearing before a Division Examiner on July 12, 1989. You are not required to attend this hearing, but as an owner of an interest that may be subject to pooling, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
