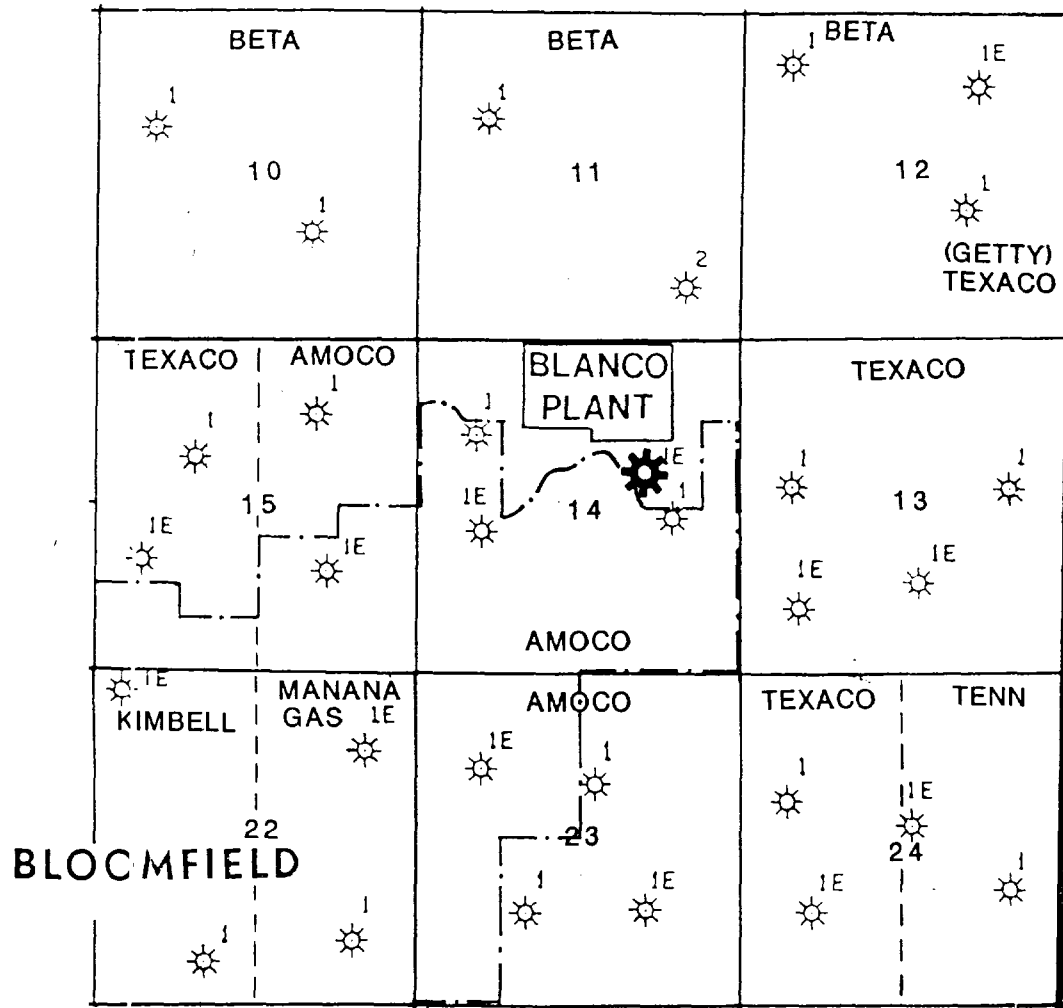

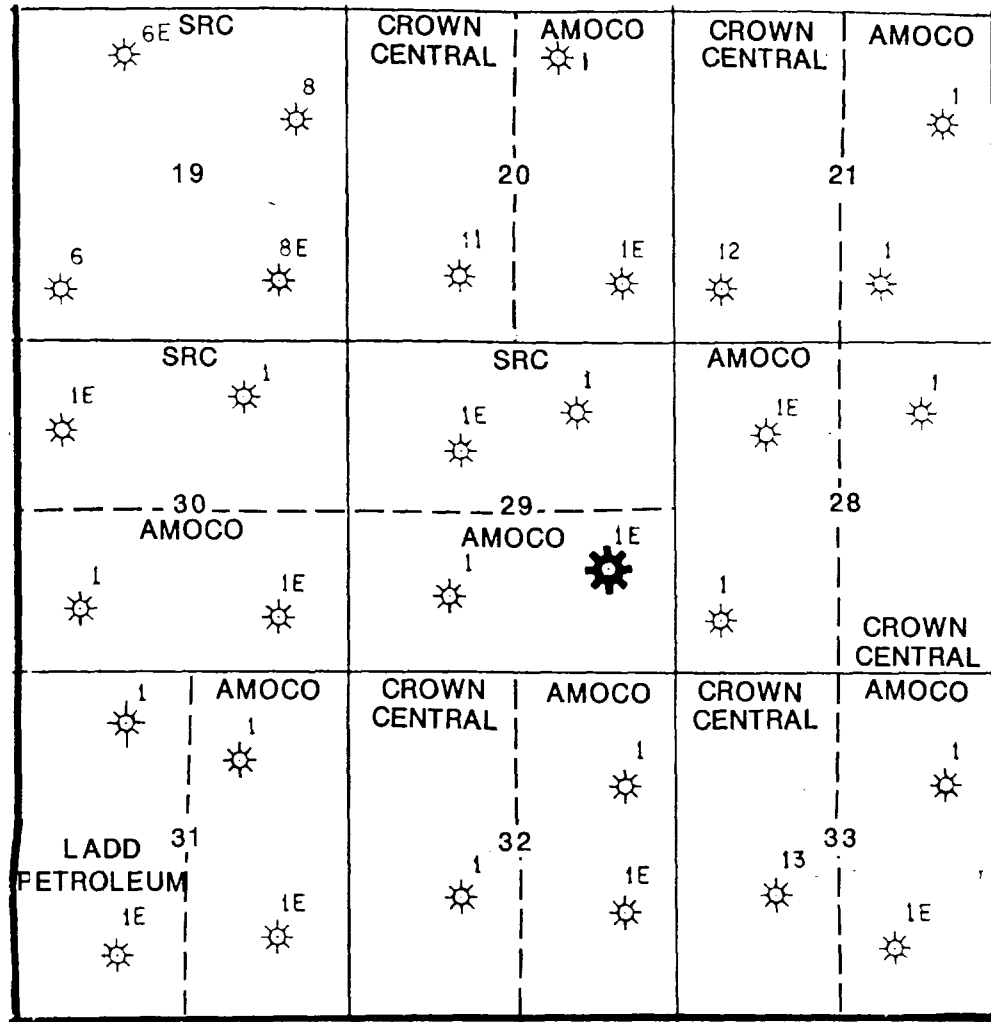

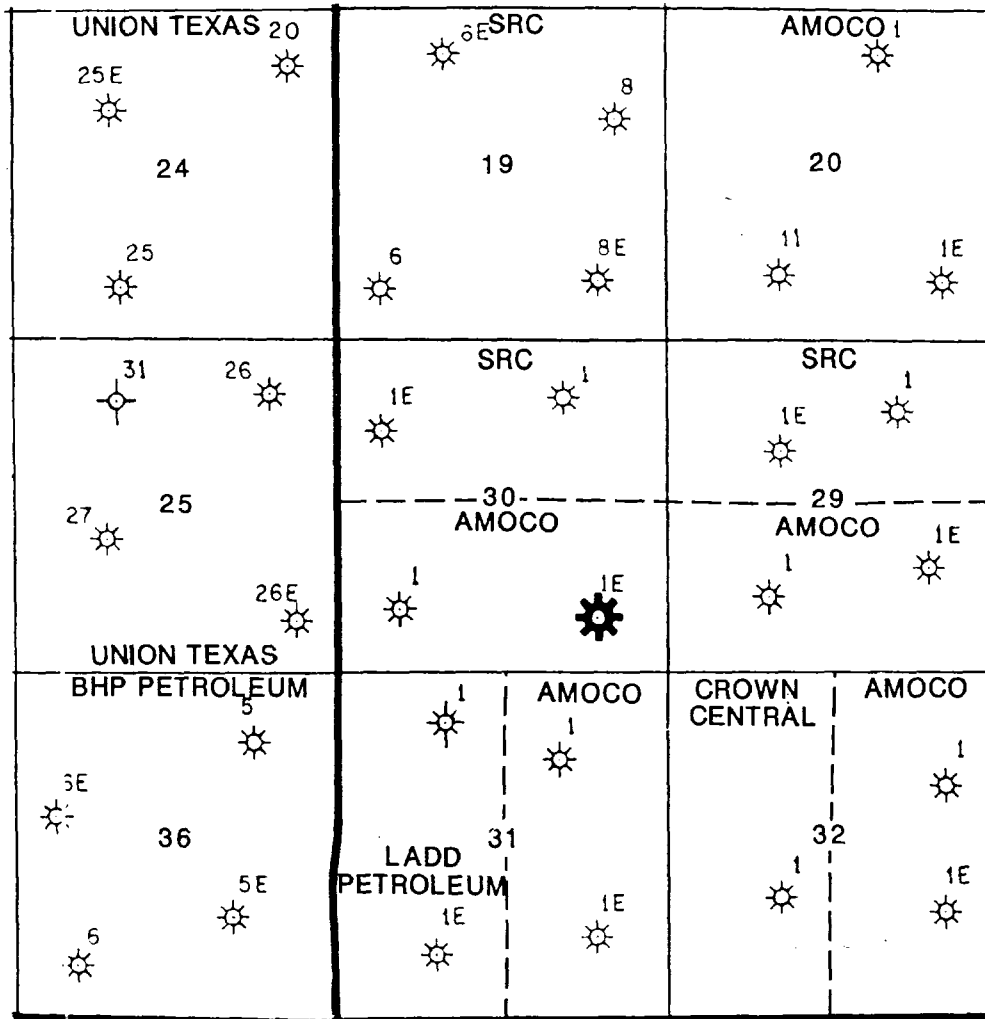
HUBBELL GAS COM "C" 1E

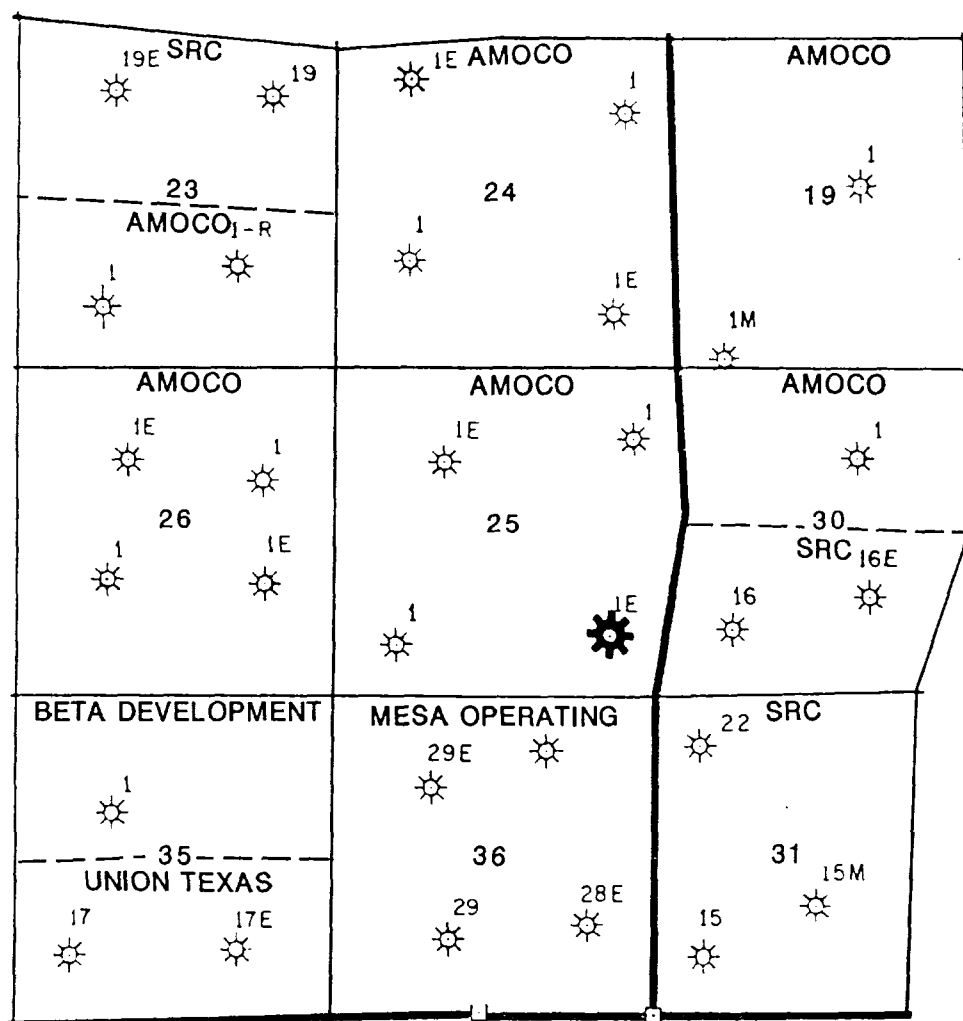

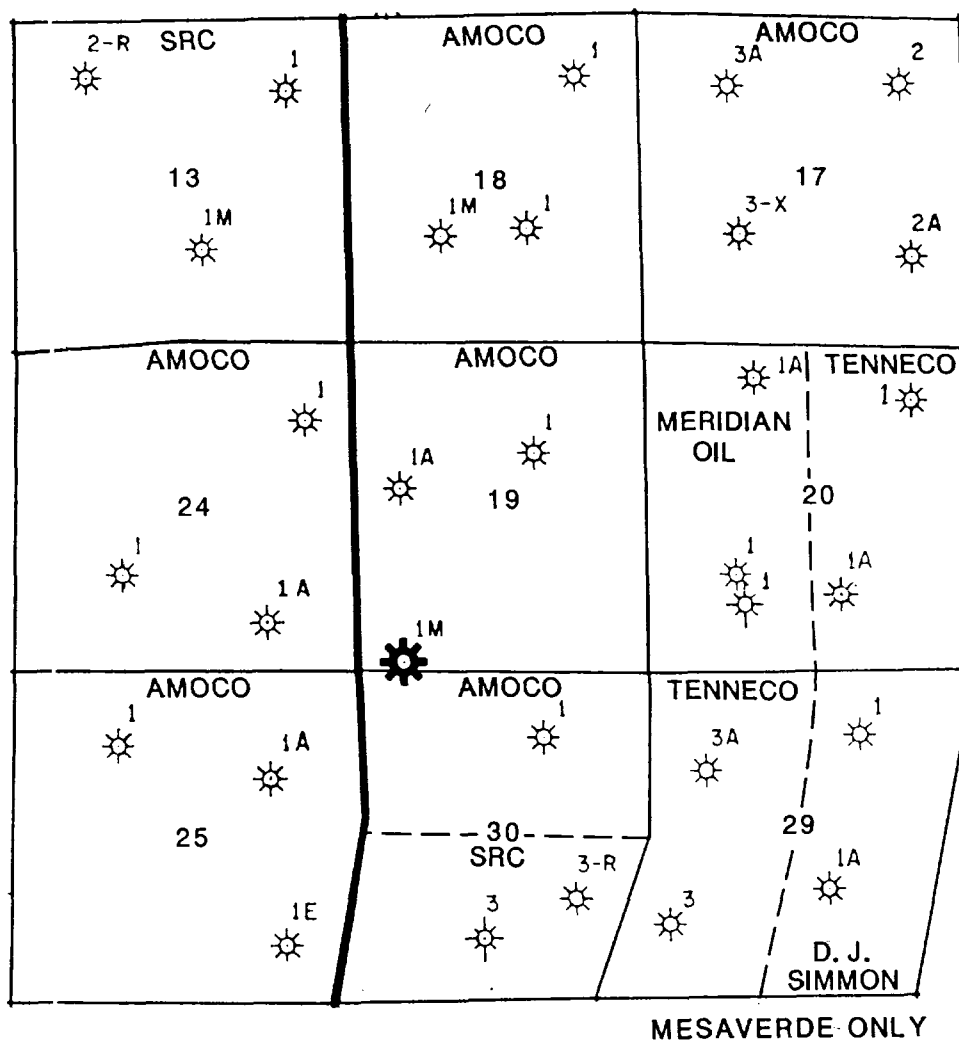

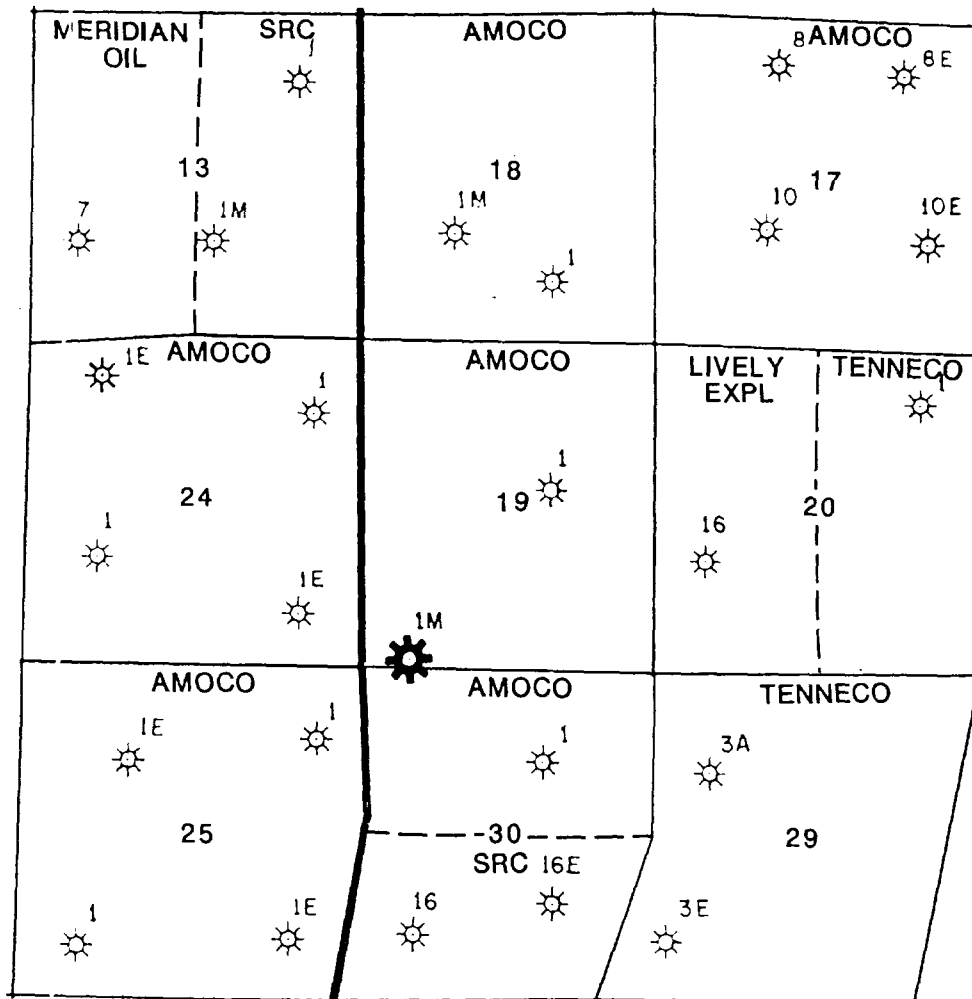
LEFKOVITZ GAS COM "B" 1E

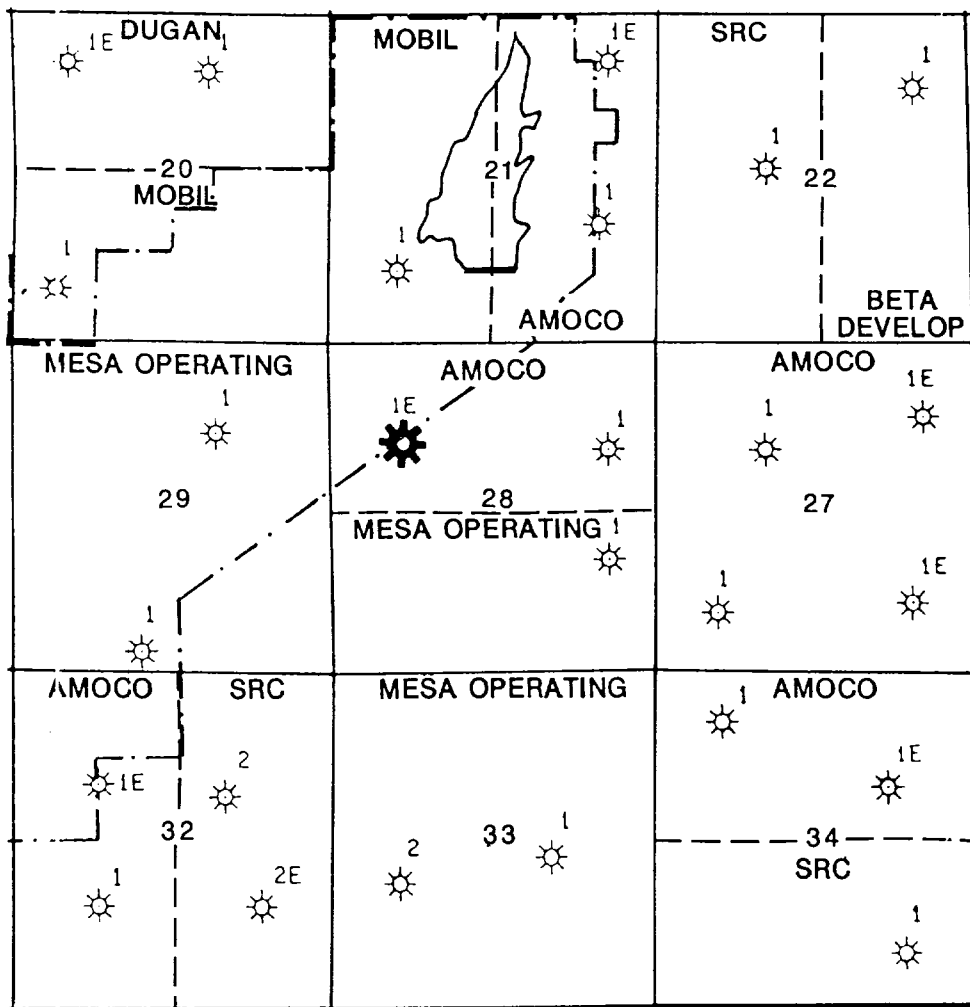
GERK GAS COM "B" 1M

CCMES NOW T. D. AUTRY who deposes and says:

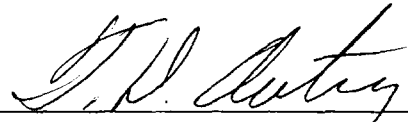
1. I am Amoco Production Company's (hereinafter referred to a "Amoco") Southern Division Production Manager. In the position of Southern Division Production Manager, I am the person responsible for the oil and gas production operations of Amoco in the San Juan Basin.

2. Amoco operates the following infill wells which are located in San Juan, County, New Mexico:

Gerk Gas Com B #1 M (Mesaverde)

3. None of the wells existing on the proration units at the time the infill wells in Paragraph 2 above were drilled have had their production restricted in any manner for purposes of avoiding the application of the New Mexico Natural Gas Protection Act to sales of natural gas from those wells.

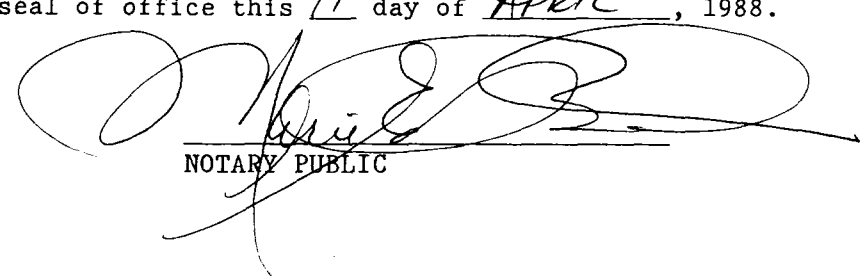
4. In each case, the drilling of each of the subject infill wells was justified for reasons other than avoiding the application of the New Mexico Price Protection Act.
