


TAHOE ENERGY, INC. hereby applies to the New Mexico Oil Conservation Division for approval of a non-standard proration unit, Lea County, New Mexico, and in support thereof would show the Division:

1. Applicant is the operator of the NE/4 of Section 15, Township 25 South, Range 37 East, N.M.P.M., Lea County, New Mexico.
2. Applicant seeks the creation of an 160-acre non-standard proration unit to be comprised of the above-referenced acreage in the Jalmat Gas Pool, to be dedicated to a well to be located at a standard location on this unit.
3. Granting the application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.
