

APPLICATION

Presidio Exploration, Inc. ("Presidio"), for its application states:

1. Presidio is the operator of Section 1, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico.
2. Presidio operates the following wells in Section 1:
 - (a) The Superior Fed. No. 8 Well, located 2130 feet FWL and 990 feet FSL, to which the S $\frac{1}{2}$ of Section 1 is dedicated; and
 - (b) The Superior Fed. No. 9 Well, located 1830 feet FNL and 1980 feet FEL, to which the N $\frac{1}{2}$ of Section 1 is dedicated.
3. Both the above wells are completed in and producing from the East Burton Flat-Strawn Gas Pool.
4. Neither of the above wells is capable of draining 320 acres.
5. Presidio requests permission to drill an infill well in the NW $\frac{1}{4}$ of Section 1 to test the Strawn formation, to dedicate the N $\frac{1}{2}$ of Section 1 to the proposed well and to the Superior Fed. No. 9 Well, and to produce both the proposed well and the Superior Fed. No. 9 Well

continuously and concurrently. Therefore, Presidio requests an exception to Division Rule 104(C)(2)(b).

6. Presidio also requests an unorthodox location of 1300 feet FNL and 1300 feet FWL for its proposed infill well.

7. The granting of this application is in the interests of conservation, will prevent waste, and will protect correlative rights.

8. Presidio requests that this matter be heard at the December 5, 1991 Examiner hearing.

WHEREFORE, Presidio requests the Division to grant the relief requested above.
