ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on February 20, 1992, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 13th day of March, 1992 the Division Director, having considered the testimony, the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) The applicant, Marbob Energy Corporation, seeks approval of an unorthodox oil well location for its State "CF" Well No. 7 to be drilled 2263 feet from the South line and 1430 feet from the East line (Unit J) of Section 13, Township 11 South, Range 27 East, NMPM, Chaves County, New Mexico.

(3) Said well is to be simultaneously dedicated, along with the State "CF" Well No. 4 located at a standard oil well location 1980 feet from the South and East lines of said Section 13, to the existing 40-acre oil spacing and proration unit comprising the NW/4 SE/4 of said Section 13.

(4) The testimony presented by the applicant indicates that the Chisum-Devonian Pool is currently a one well producing pool (that well being the aforementioned State "CF" Well No. 4) that is surrounded by "dry holes" and according

to Marbob's interpretation of this pool, a well drilled at the proposed unorthodox location is more likely to penetrate a high point in the localized reservoir up-dip of the producing well, thereby enabling the recovery of additional "attic oil" which may not otherwise be produced.

(5) The subject proration unit is within the applicant's State "CF" Lease which comprises the NE/4 and S/2 of said Section 13; therefore, the proposed location of the subject infill well is not encroaching upon any other operator.

(6) Approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the oil in the affected pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells and will otherwise prevent waste and protect correlative rights.


IT IS THEREFORE ORDERED THAT:

(1) The application of Marbob Energy Corporation for an unorthodox oil well location for the Chisum-Devonian Pool is hereby approved for its State "CF" Well No. 7 to be located at a point 2263 feet from the South line and 1430 feet from the East line of Section 13, Township 11 South, Range 27 East, NMPPM, Chaves County, New Mexico.

(2) Said well shall be simultaneously dedicated, along with the State "CF" Well No. 4 located at a standard oil well location 1980 feet from the South and East lines of said Section 13, to the existing 40-acre oil spacing and proration unit comprising the NW/4 SE/4 of said Section 13.

(3) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.




