The New Mexico Environmental Improvement Board will hold a public hearing on April 5, 6, and 7, 1994 beginning at 9:00 a.m. at the Harold Runnels Building Auditorium, 1190St. Francis Drive, Santa Fe, New Mexico, to consider the amendments to the Solid Waste Management Regulations.
