

JOE A. WILBANKS, being first duly sworn, states that:

1. I am employed as Engineering Manager by On Site Technologies, Ltd., Farmington, New Mexico and at all times material to the events which are the subject of this Affidavit I was so employed.
2. On Site Technologies, Ltd. is now and, at all times material to the events which are the subject of this Affidavit, was the agent of Snyder Oil Corporation.
3. On February 17, 1994, I gave sworn testimony as an expert petroleum engineer at a New Mexico Oil Conservation Division Examiner Hearing on Case No. 10908 -- the application of Snyder Oil Corporation for approval to downhole commingle production from the Wildcat Gallup Oil Pool and the Basin-Dakota Gas Pool within the wellbore of the Snyder Oil Corporation Con Hale #2E Well located in the SW/4SW/4 of Section 15, Township 26 North, Range 8 West, N.M.P.M., San Juan County, New Mexico.
4. During my testimony, I identified the owners of the revenue attributable to production from the Gallup and Dakota formations.

Subsequent to the New Mexico Oil Conservation Division Examiner Hearing on Case No. 10908, and for the purpose of verifying my testimony regarding the ownership of the revenue attributable to production from the Gallup and Dakota formations, I caused to be conducted a further review of the records of Snyder Oil Corporation.
6. Based on that further review, I have concluded that my testimony regarding the ownership of the revenue attributable to production from the Gallup and Dakota formations was incomplete.
7. To the best of my knowledge and belief, the current ownership of the revenue attributable to production from the Gallup and Dakota formations is as set forth on Attachment "A" to this Affidavit, which attachment is incorporated herein by reference and made a part hereof for all purposes.
