1 WHEREUPON, the following proceedings were had at
2 9:55 a.m.:

3 EXAMINER CATANACH: Let me call the hearing back
4 to order at this time, and I'm going to call Case 10,917,
5 the Application of Conoco, Inc., to reopen Case Number
6 10,917 and to amend Division Order Number R-10,071, San
7 Juan County, New Mexico.

8 This case is styled such, in the absence of
9 objection it will be taken under advisement.

10 Are there any appearances in this case at this
11 time?

12 MR. CARR: May it please the Examiner, my name is
13 William F. Carr with the Santa Fe law firm Campbell, Carr
14 and Berge.

15 We represent Conoco, Inc., in this matter, and I
16 have a brief statement.

17 Mr. Catanach, as you may recall, this case was
18 heard about 18 months ago, at which time Conoco sought
19 authority to drill a new horizontal well adjacent to its
20 Federal Com Number 8 well, an existing Fruitland Coal well,
21 in the subject spacing unit.

22 This application was approved by Order R-10,071.

23 Conoco has determined that the existing well, in
24 fact, can be used for the horizontal wellbore, and they
25 hope to re-enter that well.

1 They filed an administrative application seeking
2 authority to do this under the new Rule 111 provisions and
3 were advised by the Division that the Division preferred
4 not to amend an R order with an administrative procedure.

5 Accordingly, they requested that Conoco come
6 before you today, submit new exhibits, and then ask that
7 the case be take under advisement on the exhibits presented
8 here today.

9 I have Conoco Exhibits 1 through 9. They provide
10 all information required by the new Rule 111.

11 I also have a notice affidavit confirming that
12 notice of this Application has been provided all affected
13 interest owners in accordance with OCD rule.

14 I would note that the new Exhibit Number 4,
15 although it looks like the Exhibit C provided in the
16 original proceeding, is in fact different. And it is
17 different in that it shows correct kickoff point in the
18 well, which is at 2869 feet.

19 It is correct in the Application filed today.
20 But the prior exhibit, Exhibit C in the original case, was
21 inaccurate.

22 So with that, I would move the admission into
23 evidence of Conoco Exhibits 1 through 9 and the notice
24 affidavit.

25 EXAMINER CATANACH: Conoco Exhibits 1 through 9

1 and the notice affidavit will be submitted as evidence in
2 this case.

3 Is there anything further?

4 MR. CARR: That concludes my presentation in this
5 case.

6 EXAMINER CATANACH: Okay. There being nothing
7 further, Mr. Carr, Case 10,917 will be taken under
8 advisement.


