Gentlemen:

Responding to your telephone request of May 25, 1982, whereby El Paso proposed the shutting-in of certain wells operated by Dinero Operating Company in Eddy County, New Mexico. This is to advise you that we most emphatically urge that the following wells not be shut-in for any reason whatsoever:

Big Chief #1, 1980' FN&W of Sec. 22, T22, R-28
Big Chief #2, 1980' FN, 660 FS, Sec. 22, T22, R-28
Big Chief #3, 1980' FS&E, Sec. 21, T-22, R-28
Big Chief #4, 1980' FW, 660FS, Sec. 15, T-22, R-28
Big Chief #5, 1980' FN, 660 FW, Sec. 15, T-22, R-28
Little Squaw #1, 1980' FN&W, Sec. 27, T-22, R-28
Little Squaw #2, 1980' FW, 660FS, Sec. 27, T-22, R-28

These wells are all in the Dublin Ranch Field. It has been the experience in the area that once these wells have been placed on production and are then subsequently closed in for any reason they have become incapable of producing gas in any substantial quantity. Our Big Chief #3 wells were producing in excess of one million cubic feet per day, one was shut-in waiting for a gas connection, the other was shut-in by El Paso. I believe, because of a pipeline crowding, neither well was subsequently capable of producing 100 mcf per day and were of necessity re-completed in alternate zones which did not appear to be as good as those from which we originally completed.

For your information, we have appealed to the State of New Mexico Oil and Gas Commission to exempt the subject wells from the "Annual Shut-In Bottom Hole Pressure Tests." This request was granted, as the state did not feel that we should be subjected to the risk of losing these wells.

We certainly appreciate your consideration of this request, and sincerely hope that short of total depletion or a national disaster, these wells will never be shut-in.
