ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8 a.m. on June 20, 1984, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 28th day of June, 1984, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the remises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Rio Petro, Ltd., seeks approval of the T-4 (Enhanced Recovery) Unit Agreement covering 1,520.00 acres, more or less, of State, and Fee lands described as follows:

GUADALUPE COUNTY, NEW MEXICO

TOWNSHIP 11 NORTH, RANGE 26 EAST, NMPM

Section 8: S/2 Section 9: SW/4 Section 16: NW/4 Section 17: All

Section 18: SE/4 and S/2 NE/4

(3) That all plans of development and operation and creations, expansions, or contractions of participating areas or expansions or contractions of the unit area, should be submitted to the Director of the Division for approval.

(4) That approval of the proposed unit agreement should promote the prevention of waste and the protection of correlative rights within the unit area.

IT IS THEREFORE ORDERED:

(1) That the T-4 (Enhanced Recovery) Unit Agreement, as described below, is hereby approved:

GUADALUPE COUNTY, NEW MEXICO

TOWNSHIP 11 NORTH, RANGE 26 EAST, NMPM

Section 8: S/2 Section 9: SW/4 Section 16: NW/4 Section 17: All

Section 18: SE/4 and S/2 NE/4

Comprised of 1520.00 acres, more or less, of State and Fee lands.

- (2) That the plan contained in said unit agreement for the development and operation of the unit area is hereby approved in principle as a proper conservation measure; provided, however, that notwithstanding any of the provisions contained in said unit agreement, this approval shall not be considered as waiving or relinquishing, in any manner, any right, duty, or obligation which is now, or may hereafter be, vested in the Division to supervise and control operations for the exploration and development of any lands committed to the unit and production of oil or gas therefrom.
- (3) That the unit operator shall file with the Division an executed original or executed counterpart of the unit greement within 30 days after the effective date thereof; that in the event of subsequent joinder by any party or expansi or contraction of the unit area, the unit operator shall file with the Division within 30 days thereafter counterparts of the unit agreement reflecting the subscription of those interests having sined or ratified.
- (4) That all plans of development and operation, all unit participating areas and expansions and contractions thereof, and all expansions or contractions of the unit area, shall be submitted to the Director of the Oil Conservation Division for approval.
- (5) That this order shall become effective upon the approval of said unit agreement by the Commissioner of Public Lands for the State of New Mexico; that this order shall

terminate <u>ipso</u> <u>facto</u> upon the termination of said unit agreement; and that the last unit operator shall notify the Division immediately in writing of such termination.

(6) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
