

A P P L I C A T I O N

Comes now Robert E. Chandler Corporation and applies to the Oil Conservation division of New Mexico for an order pooling all mineral interests from the surface to base of Drinkard, underlying the NW/4NW/4 of Section 12, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico, for the formation of a proration and spacing unit for the said production, and in support thereof would show the Commission:

1. Applicant is an owner of the right to drill and develop the NW/4NW/4 of Section 12, Township 20 South, Range 38 East, NMPM.
2. Applicant proposes to drill a well at a standard location and to dedicate the NW/4NW/4 of said Section to the well.
3. Applicant has sought to obtain the cooperation of all parties.
4. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an order pooling the mineral interest involved.
