1. Consolidated Oil & Gas Inc. obtained Order R-6943-A which authorized it to use its Midway State Well No. 1 located 330 feet from the South line and 330 feet from the East line of Section 8, T17S, R37E, NMPM, to dispose of produced salt water into the Glorieta formation and provided in part that the four Midway ABO producing wells, all within a one-half mile radius of the SWD well were not adequately cemented through the injection interval.

2. Consolidated has not been able to obtain the consent of the offset operator to enter their respective wells for re-cementing of those offset wells.

3. Consolidated requests that the Division Amend Order R-6943-A to provide that those wells be closely monitored rather than re-cemented.
