APPLICATION

Comes now, DOYLE HARTMAN, by his undersigned attorneys, and hereby makes application to the New Mexico Oil Conservation Division for reinstatement of cancelled underproduction, Jalmat Gas Pool, Lea County, New Mexico, and in support thereof would show the Division:

- 1. Applicant operates the Late Thomas Wells Nos. 1, 2 and 3 located in Units M, L and J, respectively, on his Late Thomas Lease comprised of the 320 acres located in the E/2 of Section 17, Township 24 South, Range 27 East, N.M.P.M., Lea County, New Mexico.
- 2. Applicant operates the Custer State Well No. 1 located in Unit G, on his Custer State Lease comprised of the 80 acres located in the SE/4 NW/4, SW/4 NW/4 of Section 36, Township 24 South, Range 36 East, N.M.P.M., Lea County, New Mexico.
- 3. Applicant operates the Maralo State No. 1 Well located in Unit N, on his Maralo State Lease comprised of the 80 acres located in the E/2 SW/4 of Section 36, Township 23 South, Range 36 East, N.M.P.M., Lea County, New Mexico.
 - 4. That due to the refusal of the pipeline to take the gas

allowable assigned to each of the proration units described in paragraphs 1, 2 and 3 above, the units were at various times since mid-1982 reclassified from non-marginal status to marginal status.

- 5. That each of the units was subsequently reclassified back to non-marginal status, but the accrued underproduction for each of these proration units was not reinstated resulting in the loss to applicant of millions of cubic feet of gas which he had previously been entitled to produce.
- 6. Applicant seeks an order reinstating the cancelled underproduction for its Late Thomas Lease, Custer State Lease, and Maralo State Lease.
- 7. That granting this application will not cause waste nor impair the correlative rights of any interest owner in the Jalmat Gas Pool.

WHEREFORE, applicant requests that this matter be set for hearing on October 3, 1984, before a duly appointed Examiner of the Oil Conservation Division, and that after notice and hearing as required by law, the Division enter its order reinstating the previously cancelled underproduction for the Late Thomas Lease, Custer State Lease and Maralow State Lease in the Jalmat Gas Pool.
