Gentlemen:

The Bureau of Land Management has notified this office that the N.E. Salado Draw (Deep) Unit agreement has been terminated effective as of February 25, 1986.

The N.E. Salado Draw (Deep) Unit was approved on October 26, 1984, effective as of October 30, 1984. The term of the agreement is contingent upon the unit operator drilling one well at a time, allowing not more than six months time between the completion of one well and the beginning of the next, until a well capable of producing unitized substances in paying quantities is completed.

Our records also indicate that the Unit Well No. 1 was tested on August 25, 1985 and your proposed well No. 2, located in the SE/4 SE/4 Sec. 36-T25S-R33E was never drilled.

In View of the above, please be advised that the Commissioner of Public Lands has also terminated the N.E. Salado Draw (Deep) Unit, effective as of February 25, 1986, being six months from the date the Well No. 1 was completed.
