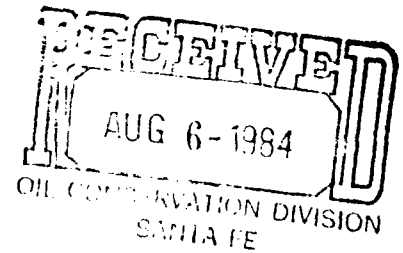



Gentlemen:

Pursuant to the provisions of the New Mexico Oil Conservation Commissions Order 5436, Section 62-7-5 NMSA 1978, Union Texas Petroleum Corporation requests an exemption for the above referenced well from the provisions of the New Mexico Gas Pricing Act.

Attached for your consideration is the following:

- (1) An area plat showing the referenced proration unit, the location of all wells thereon, location and ownership of all wells offsetting it.
- (2) The well site plat for the original well. (Form C128).
- (3) The well site plat for the replacement well.
- (4) A copy of the AFE for the Jicarilla "G" No. 2R well.
- (5) Proof that the well has been plugged and abandoned before the replacement well was drilled. (Form 9-331 dated 10-1-76)
- (6) Proof of the date when the well was drilled. (Form 9-331 dated 2-8-78)

The Jicarilla "G" No. 2 well produced from September 1958 until March 1967. The well had a sudden influx of water and we were unable to get the well to produce gas. A swabbing unit was moved onto the well and the water level was found to be standing at 1300 feet. The well was swabbed for several days and the water level could not be lowered below 1700' with no gas shows. We then ran a casing inspection log in the hole and found a casing leak at 3100 feet. Rigged up and squeezed casing leak at 3100 feet with 50 sx of Class "C" cement. Squeeze held. Went in the hole and perforated four squeeze holes in the casing at 3950 feet. Rigged up and squeezed with 200 sx of cement. Squeeze held. Cleaned out and ran tubing to 4,000 feet. A down hole pump, rods and a pumping unit were installed and water pumped off the formation. The pumping unit was used intermittently for several months with negative results. Gas flow could not be restored.


The well was plugged and abandoned 10/31/66 (see Form 9-331 dated 12/1/76).

The application to drill the Jicarilla "G" No. 2R was filed 10/7/77 and approved for drilling (see Form 9-331C) on 10/11/77. This well was spudded on 11/9/77 (see Form 9-331 dated 11/14/77) and approved 11/15/77. The well was completed on 1/18/78 (see Form 9-331 dated 2/8/78). This well was first produced into the Gas Company of New Mexico gathering system on April 6, 1978.

Union Texas Petroleum Corporation respectfully requests this exemption be approved as soon as practical.





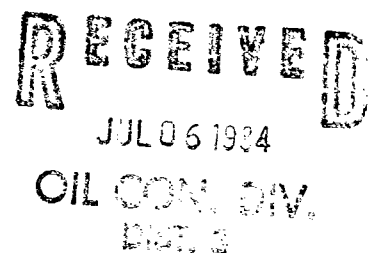

Pursuant to the provisions of the New Mexico Oil Conservation Commissions Order 5436, Section 62-7-5 NMSA 1978, Union Texas Petroleum Corporation requests an exemption for the above referenced well from the provisions of the New Mexico Gas Pricing Act.

Attached for your consideration is the following:

- (1) An area plat showing the referenced proration unit, the location of all wells thereon, location and ownership of all wells offsetting it.
- (2) The well site plat for the original well. (Form C128).
- (3) The well site plat for the replacement well.
- (4) A copy of the AFE for the Jicarilla "G" No. 2R well.
- (5) Proof that the well has been plugged and abandoned before the replacement well was drilled. (Form 9-331 dated 10-1-76)
- (6) Proof of the date when the well was drilled. (Form 9-331 dated 2-8-78)

The Jicarilla "G" No. 2 well produced from September 1958 until March 1967. The well had a sudden influx of water and we were unable to get the well to produce gas. A swabbing unit was moved onto the well and the water level was found to be standing at 1300 feet. The well was swabbed for several days and the water level could not be lowered below 1700' with no gas shows. We then ran a casing inspection log in the hole and found a casing leak at 3100 feet. Rigged up and squeezed casing leak at 3100 feet with 50 sx of Class "C" cement. Squeeze held. Went in the hole and perforated four squeeze holes in the casing at 3950 feet. Rigged up and squeezed with 200 sx of cement. Squeeze held. Cleaned out and ran tubing to 4,000 feet. A down hole pump, rods and a pumping unit were installed and water pumped off the formation. The pumping unit was used intermittently for several months with negative results. Gas flow could not be restored.

The well was plugged and abandoned 10/31/66 (see Form 9-331 dated 12/1/76).

The application to drill the Jicarilla "G" No. 2R was filed 10/7/77 and approved for drilling (see Form 9-331C) on 10/11/77. This well was spudded on 11/9/77 (see Form 9-331 dated 11/14/77) and approved 11/15/77. The well was completed on 1/18/78 (see Form 9-331 dated 2/8/78). This well was first produced into the Gas Company of New Mexico gathering system on April 6, 1978.

Union Texas Petroleum Corporation respectfully requests this exemption be approved as soon as practical.





In reviewing applications by Union Texas Petroleum for exemptions from the provisions of the New Mexico Natural Gas Pricing Act, I came across two wells which I believe do not need exemptions as they are not properly considered infill wells. Both of these wells, the Jicarilla "H" No. 6Y and the Newsom "B" No. 1R, were drilled after the intended original well was completed as a dry hole. These original wells were plugged and abandoned without production. Because there was never any production, the wells for which exemption applications have been filed were not drilled on a proration unit that was producing or capable of producing gas and thus are not infills needing exemption.

If you agree with this analysis please let me know and we will dismiss the application as to these wells.

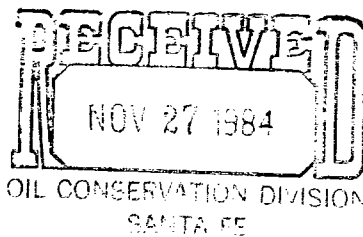
