

A P P L I C A T I O N

Comes now Chaveroo Operating Company, Inc., by and through its attorneys, Kellahin & Kellahin, and applies to the New Mexico Oil Conservation Division for approval of five unorthodox oil well locations, Roosevelt County, New Mexico, and in support thereof would show:

1. Applicant is the operator of certain oil wells all located in Township 7 South, Range 32 East, NMPM, Roosevelt County, New Mexico.

2. Applicant desires to drill five additional oil wells all within T7S, R32E, each at an unorthodox location as follows:

1. Anderson State No. 10
1310 FNL and 1310 FEL (NE/4NE/4) of Section 36
2. Humble Federal Well No. 9
1310 FNL and 1310 FWL (NW/4NW/4) of Section 25
3. Tucker No. 5
1310 FWL and 1310 FSL (SW/4SW/4) of Section 24

4. Tucker Hall No. 9
1310 FNL and 1310 FEL (NE/4NE/4) of Section 25

5. KMS No. 6 Well
2630 FNL and 1310 FWL (SW/4NW/4) of Section 36

3. With the exception of the KMS No. 6 well, the subject wells are all 40-acre spaced oil wells to be drilled to a depth of approximately 4,450 feet to test the San Andres formations.

4. That because of a difference in ownership, applicant desires to form a nonstandard 160 acre proration and spacing unit consisting of the following acreage to be dedicated to the KMS No. 6 well:

Section 36: SW/4NW/4
SE/4NW/4
NW/4SW/4
NE/4SW/4

5. That approval of this application will be in the best interests of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, applicant requests that this matter be set for hearing and that after notice and hearing the application be granted.
