Re: Unorthodox Location Chaves County, New Mexico

Gentlemen:

As a follow-up to our telephone conversation and request on January 7, 1985, please include on your January 31st hearing schedule Bison Petroleum Corporation's request for drilling a well at the following unorthodox location:

> 1200' FWL 1980' FNL Section 34, T13S, R30E Chaves County, New Mexico

The subject location is critical in that there is gas up-dip and water down-dip. An anticipated oil completion will justify this development well but a gas well, though economic, would not. Hence, it is necessary to drill the well at the best geological location.

The location is 660 feet from the nearest lease line and is unorthodox only in that it is not near the center of a quarter-quarter section.

We anticipate spudding in early February; if there are any problems with the date or if you have any questions please call collect at the letterhead address.
