Gentlemen:

I am writing to update each of you as to the status of the Continental Divide #1 well which we had hoped to spud prior to the end of 1985.

Enclosed for your files are original counterpart signature pages to the Operating Agreement from the parties which have joined to date. Reading & Bates has yet to send in their pages and we have made efforts, which have proved to be futile, to contact the principles of Mountain States Natural Gas. We have been unable to get Mountain States to respond at all as to their election to join and are preparing to force pool their interest. The force pool hearing is set for January 22, 1986 in Santa Fe.

Also enclosed is a revised page 5 to the Operating Agreement wherein we have changed the non-consent penalty applicable to intangibles on future wells from 500% to 300% at the request of Hooper, Kimball, and Williams, Inc. A copy of Hooper's letter is enclosed for your files and we ask that you insert the revised page into your copy of the Operating Agreement provided you have no objections to said revision.

You will also note that a new page 2 to the Exhibit "A" is attached. This was necessitated by virtue of the fact that we had to correct the addresses for Mr. Ralph Gilliland as well as the Clark & Oatman group. Please insert it into your Operating Agreement as well.

With respect to the progress of the well, we have encountered an unavoidable delay. In surveying the location and the road necessary to reach said location, it became obvious that the only entry into the location is from the east. Unfortunately, Sections 6 and 7 of Township 25 North, Range 1 West which are east of our Section 12 location are in the Santa Fe National Forest. We were aware of this fact in October, 1985 and have been working with the Forest people since that time to gain access to our location per their requirements. The unavoidable part of our situation is the fact that once the first snowfall occurred in early December, the Forest Service put the halt on any future operations until Spring. We have made every effort we
