Dear Sir:

This letter will acknowledge receipt of your copy of application seeking to obtain permission from the Oil Conservation Division to convert the above well to a saltwater injection well.

Because an oil and gas lease is entitled to use so much of the land as is necessary to explore for and remove the oil and gas, he does not need additional permission of the Commissioner to dispose of the Salt Water upon or under the leased land so long as the water being disposed of is produced exclusively from wells located on the leased premises. However, if any of the saltwater to be injected is produced from land not under the applicants state oil and gas lease, then the applicant, in addition to a disposal site easement, will be required to secure a regular right-of-way easement for a pipeline, roadway, or other means of conveyance under the rules pertaining to right-of-way.

Although, we have no objections at this time for the Oil Conservation Division to grant you permission to convert the aforesaid well to a water injection well the Land Commissioner reserves the right to refuse to grant an easement when to do so would be detrimental to the Trust.

If your application is approved by the Oil Conservation Division and you are going to be injecting saltwater from wells located outside of the leased premises you have to complete and

return this forms with a \$300.00 fee. This fee covers (\$250.00) first annual rental, (\$20.00) appraisement fee and (\$30.00) filing fee.

If and when approved the saltwater disposal easement will be issued for one year.



Re: Conversion of the State Y No. 1 Well to Salt Water Disposal.

Gentlemen:

This letter is in response to your letter of November 14, 1986, to Doyle Hartman, Oil Operator, concerning your plans to convert the State Y No. 1 Well located in Unit D of Section 36, Township 24 South, Range 36 East, N.M.P.M., Lea County, New Mexico, to salt water disposal. This well is an immediate offset to the Hartman Custer State No. 1 which, although it has been shut-in during the last few months due to El Paso's refusal to purchase gas therefrom under its Purchase Agreement with Hartman, is a top allowable well in the Jalmat formation. Your proposal will result in the disposal of produced water into the formation from which the Custer State No.1 produces. Disposal into this zone will drastically reduce the already short life of this well, will result in the waste of hydrocarbons and impair the correlative rights of the interest owners in the Custer State No. 1.

As you may not be aware, we are currently involved in litigation with El Paso Natural Gas concerning its production policies in relationship to the Custer State No. 1 and other wells. One of the issues in this litigation is the water problem that we are having in the Jalmat reservoir. The disposal of water in the State Y No. 1 as you propose will only aggravate that problem. We have a disposal well in the area and would be willing to discuss with you an arrangement whereby you could utilize our disposal well. A reasonable fee for disposal would, of course, be charged.

We are hopeful that this matter can be resolved without our having to oppose an application for disposal of produced water in the State Y No. 1 at the Oil Conservation Division. If, however, you proceed with your plans, we will have no alternative but to vigorously oppose this proposal.
