

A P P L I C A T I O N

Comes now MARATHON OIL COMPANY, by and through its Attorneys, Kellahin, Kellahin & Aubrey, and applies to the New Mexico Oil Conservation Division for an order creating a new oil pool for the Siluro-Devonian formation, comprising the S/2SE/4 of Section 14, T16S, R38E, NMPM, and the promulgation of temporary special rules and regulations therefore, including a provision for 80-acre spacing and proration units and designated well locations requirements, and in support thereof would show:

1. Applicant is the operator of the Benson #1 Well located in Unit P, Section 14, T16S, R38E, Lea County, New Mexico.

2. The Applicant has drilled and completed the subject well in the Siluro-Devonian formation.

3. The subject well constitutes the discovery of a new Siluro-Devonian oil reservoir.

4. In order to effectively, efficiently and economically operate, develop, and produce this reservoir, special rules and regulations should be adopted, including a provision for 80-acre spacing and proration units.

5. The Special rules and regulations should be established for a temporary period of 24 months in which to adequately develop data concerning this reservoir.

WHEREFORE, Applicant requests that the Division set this matter for hearing and that after notice and hearing the application be granted as requested.
