## APPLICATION FOR HEARING DE NOVO

COMES NOW the Applicant, BCO, INC., by and through its attorneys, Jones, Snead, Wertheim, Rodriguez & Wentworth, P.A., and pursuant to Rule 1220 of the Oil Conservation Division, requests that the above-captioned case be heard <u>de novo</u> before the Commission, and as grounds therefor states:

1. On July 8, 1988, Order No. R-8694 was entered by the Division pursuant to a hearing held before examiner Michael E. Stogner.

2. In Order No. R-8694, the Division denied the Application of BCO, INC. seeking a modification of the standard 40 acre spacing requirements for its State "J" Well No. 1, located in the NE/4 NE/4 of Section 16, T23N, R7W, NMPM, Rio Arriba County, New Mexico. By its Application, BCO, INC. sought the dedication of an additional 40 acres (NW/4 NW/4) to the standard 40 acre unit, thereby forming a non-standard 80 acre oil spacing and proration unit consisting of the N/2 NE/4 of Section 16, and making such order retroactive to the date of first production, October 13, 1987. The Application was not opposed by any offset operator or other interest owner.

3. BCO, INC. is a party adversely affected by Order No. R-8694, and pursuant to Rule 1220 of the Oil Conservation Division, BCO, INC. elects to exercise its right to have this case heard <u>de novo</u> before the Oil Conservation Commission.

4. This application has been filed with the Division within thirty (30) days of the date of Order No. R-8694 as
