#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on July 26, 1989, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 27th day of July, 1989, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of Ingle Wells-Delaware Pool. Said Ingle Wells-Delaware Pool was discovered by the Texaco Production Inc. Todd 2 State Well No. 1, located in Unit F of Section 2, Township 24 South, Range 31 East, NMPM. It was completed in the Delaware formation on May 17, 1989. The top of the perforations is at 7,210 feet.
- (3) There is need for the dismissal of the proposed extension to the East Burton Flat-Wolfcamp Gas Pool in Eddy County, New Mexico, pending further study.

- (4) There is need for the dismissal of the proposed extension to the Comanche Springs-PrePermian Gas Pool in Chaves County, New Mexico, pending further study.
- (5) There is need for certain extensions to the Diablo-San Andres Pool, the Foor Ranch-PrePermian Gas Pool, and the Foor Ranch-Wolfcamp Gas Pool, all in Chaves County, New Mexico, and the Burton Flat-Atoka Gas Pool, the Burton Flat-Morrow Gas Pool, the East Burton Flat-Morrow Gas Pool, the Cemetery-Morrow Gas Pool, the Collins Ranch-Wolfcamp Gas Pool, the Indian Basin-Morrow Gas Pool, the East Loving-Delaware Pool, the Palmillo-Upper Pennsylvanian Pool, the Parkway-Delaware Pool, the Red Lake Atoka-Morrow Gas Pool, the Seven Rivers-Yeso Pool, and the North Shugart-Bone Spring Pool, all in Eddy County, New Mexico.

#### IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production is hereby created and designated as the Ingle Wells-Delaware Pool, consisting of the following described area:

(b) The Burton Flat-Atoka Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(c) The Burton Flat-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

### TOWNSHIP 20 SOUTH, RANGE 28 EAST, NMPM Section 9: W/2

(d) The East Burton Flat-Morrow Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(g) The Collins Ranch-Wolfcamp Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

- (h) The proposed extension to the Comanche Springs-PrePermian Gas Pool in Chaves County, New Mexico, is hereby dismissed.

(m) The East Loving-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(n) The Palmillo-Upper Pennsylvanian Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(o) The Parkway-Delaware Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(q) The Seven Rivers-Yeso Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(r) The North Shugart-Bone Spring Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

### TOWNSHIP 18 SOUTH, RANGE 31 EAST, NMPM Section 7: NW/4

#### IT IS FURTHER ORDERED THAT:

- (1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations and extensions included herein shall be August 1, 1989.
