


Dear Mr. Vandiver:

I just received your letter dated February 1, 1991 requesting the subject case be continued to the February 21, 1991 Examiner Hearing. At this time the docket for the February 21st hearing contains several extensive cases which involve the review of the Basin-Fruitland Coal Gas Pool (Case 9420), statutory unitization of 13,385 acres (Case 20253) and a waterflood project for 108 wells (Case No. 10252).

It is anticipated that these three cases alone will take a full day for testimony, possibly longer. With the other cases docketed for this hearing it is possible that it will continue into Saturday.
