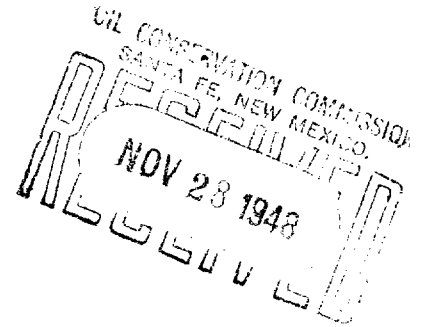

With reference to the Lindrith Unit Area, we would appreciate your verifying the total acreage involved in this area before the order is written.

In the Unit Agreement itself the total acreage is shown as 28,499.41 acres, more or less. The petition breaks down the ownership among Federal, State and private lands - 22,379.49; 6,039.90 and 40 acres which makes a total of 28,419.79. Your total shows 28,459.39 acres.

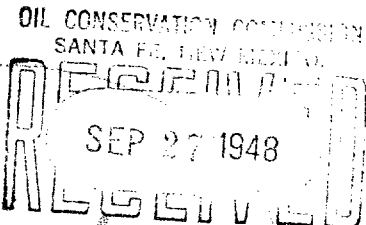
