

Gentlemen:

Pursuant to Section 10 of the captioned Unit Agreement, J. Glenn Turner, as Sub-Operator for the development and production of natural gas and associated liquid hydrocarbons from all formations down through the Pictured Cliffs Formation within the captioned Unit Area, herewith submits his proposed drilling program for the balance of the calendar year, 1954.

By Designation, dated October 13, 1954, Magnolia Petroleum Company, as the Unit Operator under the captioned Unit Agreement, has designated the undersigned, J. Glenn Turner, as Sub-Operator for the development and production of natural gas and associated liquid hydrocarbons from all formations down through the base of the Pictured Cliffs Formation, such Designation having been accepted by the Director of the U. S. Geological Survey on October 26, 1954.

Based upon prior development of the Huerfanito Unit Area and upon recent developments of the Pictured Cliffs Formation in areas offsetting the subject Unit Area, J. Glenn Turner hereby submits, for your consideration and approval, a drilling program for the balance of the calendar year, 1954, which would provide for the drilling of nine Pictured Cliffs Formation wells within the Unit Area, the location and designation of such wells being as follows:

Crandell-Federal No. 1-10, NW/4 Sec. 10, T-26-N, R-9-W
Crandell-Federal No. 2-10, NE/4 Sec. 10, T-26-N, R-9-W
Ballard-Federal No. 1-11, NW/4 Sec. 11, T-26-N, R-9-W
Ballard-Federal No. 2-11, NE/4 Sec. 11, T-26-N, R-9-W
Ballard-Federal No. 1-12, NW/4 Sec. 12, T-26-N, R-9-W
Ballard-Federal No. 2-12, SW/4 Sec. 12, T-26-N, R-9-W
Ballard-Federal No. 3-12, NE/4 Sec. 12, T-26-N, R-9-W

It is apparent, from recent developments in this area, that the southern portion of the Unit Area may prove to be more productive of natural gas than has been the case in the development of the northeasterly portion of the Unit Area. It is proposed that each of such wells shall be drilled with rotary tools to a depth of approximately 2,000 feet and set 5-1/2 inch casing on the top of the Pictured Cliffs Formation, following which the hole shall be deepened with cable tools. Upon reaching the base of the Pictured Cliffs Formation, the Operator shall then conduct sand-oil fracing operations, using a minimum of 4,500 pounds of sand and 8,000 gallons of Diesel oil as the proposed formation treatment.

In the event the drilling operations contemplated hereby encounter marginal production, it is proposed that auxillary locations will be selected, subject, however, to your like approval.

If the proposed drilling program, as outlined hereinabove, is acceptable to you please indicate your approval

thereof in the space provided below and return one approved copy to the undersigned, J. 


