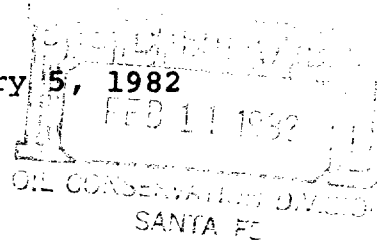

NOTICE OF COMPLETION OF ADDITIONAL
WELLS, Mesaverde and Dakota Formations

Gentlemen:

Pursuant to Section 11(a) of the captioned Agreement, approved September 3, 1954, El Paso Natural Gas Company, as Unit Operator, determined on the dates set out below that two (2) additional wells capable of producing unitized substances from the Dakota Formation have been completed upon acreage committed to the Unit. One well, the #32A, is also capable of producing unitized substances from the Mesaverde Formation. These wells are as follows:

The San Juan 29-7 Unit #32A Well, located 1850' from the North line and 1770' from the West line of Section 32, Township 29 North, Range 7 West, N.M.P.M., was spudded on September 11, 1980, and completed on July 17, 1980, at a plugged back depth of 7827'. The Mesaverde Formation at the selected intervals between 4965' and 5874' was treated with a sand-water fracturing process on June 17, 1980. The well was shut-in on June 24, 1980, and after being shut-in for twenty-three (23) days, the Mesaverde Formation was tested on July 17, 1980, using the Pitot tube method with an after frac guage of 9925 MCF/D, with an SIPC of 944 psia and an SIPT of 889 psia. The Dakota Formation at the selected intervals between 7575' and 7780' was treated with a sand-water fracturing process on June 16, 1980. The well was shut-in on June 24, 1980, and after being shut-in for fifteen (15) days, the Dakota Formation was tested on July 9, 1980, using the Pitot tube


method with an after frac guage of 10738 MCF/D with an SIPT of 1006 psia. The spacing unit for this well is described as the W/2 of Section 32, Township 29 North, Range 7 West, N.M.P.M., containing 320.00 acres.

The San Juan 29-7 Unit #116 Well, located 800' from the South line and 1250' from the West line of Section 30, Township 29 North, Range 7 West, N.M.P.M., was spudded on September 6, 1979, and completed on March 25, 1980, at a plugged back depth of 7443'. The Dakota Formation at the selected intervals between 7209' and 7389' was treated with a sand-water fracturing process on March 16, 1980. The well was shut-in on June 18, 1980, and after being shut-in for nine (9) days, the Dakota Formation was tested on June 26, 1980, using the Pitot tube method with an after frac guage of 337 MCF/D, with an SIPC of 2512 psia and an SIPT of 760 psia. The spacing unit for this well is described as the W/2 of Section 30, Township 29 North, Range 7 West, N.M.P.M., containing 246.88 acres.

Both of the drilling blocks for the above-described wells are included within the existing Dakota and Mesaverde Participating Areas, therefore, the Dakota and Mesaverde Participating Areas are not enlarged by these wells.
