MR. MORRIS: Application of Perry R. Bass for a
unit agreement, Lea County, New Mexico.

MR. BRATTON: Howard Bratton on behalf of the
applicant.

Exhibits 1 and 2 marked for
identification.)

MR. UTZ: Are there any other appearances in this
case? You may proceed.



FLOYD ACKLIN, called as a witness, having been first duly sworn, was examined and testified as follows.

DIRECT EXAMINATION

BY MR. BRATTON:

Q Will you state your name, by whom you are employed, and in what capacity?

A Floyd Acklin, A-c-k-l-i-n. Employed by Perry R. Bass, chief geologist.

Q Have you previously testified before this Commission?

A I have not.

Q Will you state briefly your educational and professional background?

A I received a B. A. Degree in geology from Texas Christian University in 1950. I have been employed by the Richardson and Bass interests since that time.

Q In the capacity of geologist?

A Yes.

Q Are you familiar with the proposed Plains Unit area?

A Yes.

Q And the application under consideration here?

A Yes.

MR. BRATTON: Are the witness's qualifications acceptable?

MR. UTZ: Yes, sir, they are.

Q Mr. Acklin, are you familiar with the proposed Plains Unit Agreement, the terms thereof?

A Yes, sir.

Q That has been marked as Applicant's Exhibit Number 1. I will ask you, Mr. Acklin, is the area covered by it shown as Exhibit A to the unit agreement?

A Yes.

Q That's the area within the dark blue outline on the Exhibit A?

A That is correct.

Q How many acres does that total?

A 7,198.01.

Q Is all that acreage federal acreage?

A That is correct.

Q As to the unit itself, Mr. Acklin, is it a standard federal form of unit agreement?

A It is.

Q Has it been submitted to the United States Geological Survey for approval as to the form and area?

A Yes.

Q Has it been so approved?

A It has been approved.

Q What does it call for in the way of a well test?

A It calls for a well to test the Mississippian lime

but not to exceed 13,000 feet.

Q That's within six months after the approval of the unit?

A That is correct.

Q What is the status of commitment to the unit, first as to your working interest?

A All of the working interest has been committed with the exception of a Mobil tract which , I forget the number.

Q Is that tract Number 7?

A Tract Number 7 containing approximately 600 acres. They have advised that they may join at a later date, but not at this time. And the Sharon Tract, composed of 320 acres, they have been noncommittal.

Q What percentage of commitment to the unit does that give you?

A Approximately 88 percent.

Q How about your overriding royalty interest, what's the percentage of commitment?

A At the present time practically all of it has been approved and, of course, we expect one hundred percent by the time of final approval.

Q You have not been turned down on any override?

A No.

Q The Unit Agreement has the standard provisions for

subsequent joinder?

A Right.

Q And non-joinder?

A Yes.

Q Refer to your Exhibit Number 2, Mr. Acklin, and explain what that is, please.

A This is a seismic map made on approximately the top of the Mississippian showing the depth contours, the proposed location site along with the proposed unit outline as shown in red.

Q What type of structure formation does this indicate?

A It indicated an anticline between fault blocks, faulted anticline type of structure.

Q This was done on the basis of seismic work done for the participants in the unit?

A Yes, that's correct.

Q In your opinion, Mr. Acklin, does this seismic structure map indicate that the unit outlines correspond to the formation?

A Yes, it does in my opinion.

Q That it includes the formation and nothing more or nothing less?

A Right.

Q In your opinion, Mr. Acklin, will operations under



the proposed unit be in the interest of conservation and the protection of correlative rights?

A Yes.

Q Do you feel that the percentage of commitment gives you effective control to run a satisfactory unit operation?

A Very definitely.

Q I won't ask you if you prepared the unit agreement. Are you familiar with the Unit Agreement and also with the seismic map?

A Yes.

Q Those are presented on behalf of the Unit?

A Right.

Q Mr. Perry Bass will be the operator of the Unit?

A That is correct.

MR. BRATTON: We will offer in evidence Exhibits No. 1 and 2.

MR. UTZ: Without objection Exhibits 1 and 2 will be entered into the record in this case. Are there questions of the witness?

MR. MORRIS: No questions.

CROSS EXAMINATION

BY MR. UTZ:

Q I can't let you off without asking you one question. I was wondering if the section lines on this Unit on the west

A I'd have to say no to that.
