 - (1) Any bond, mortgage, mortgage certificate, mortgage participation, judgment, lien, note, certificate of indebtedness, certificate of interest or other instrument, evidencing any indebtedness secured on or by any property and any interest therein, whether for principal or income; and

(v) To make gifts or allowances of money or property to anyone or for charitable, educational, religious, public or other purposes.

Consideration

(w) To exercise any of the foregoing powers and authorities and enter into any of the foregoing transactions on any terms and conditions, at any prices, whether for cash, on credit, or without any consideration, and for any period or periods, as my attorney may, in his sole and unlimited discretion, indeed expedient, necessary, proper or advisable.

Signatures

(x) To sign my name without indicating that he is doing so for me and to exercise any and all of the powers and do any and all of the acts herein authorized either in my name or in his name, with or without the use of the designation "attorney."

Attorney's self-interest

(y) To determine what acts, instructions or policies are expedient, necessary, proper or advisable and to do any act hereby authorized or exercise any authority hereby granted notwithstanding that the same may appear to be or be for or to the personal use, benefit, advantage, order or account of my said attorney, and the powers and authorities herein granted shall not be limited nor restricted by any direct or indirect interest, adverse or otherwise, of my said attorney.

Substitution

(z) To appoint, by instrument in writing (which need not be acknowledged before a notary public or other official), a substitute or substitutes with power and authority to act hereunder, in his place and stead, and with all or any of the powers and authority of my attorney, provided, however, that my attorney may limit, by any instrument of substitution, the duration and extent of the powers and authority of the substitute or substitutes therein named, and any such limitations, so provided, shall be effective to restrict the duration and extent of the powers and authority of such substitute or substitutes to those specifically set forth in the instrument of appointment. 2. In interpreting this instrument, the singular shall be deemed to include the plural; the disjunctive shall be deemed to include the conjunctive; and the masculine shall be deemed to include the feminine and neuter and vice versa; except where plainly indicated to the contrary, either expressly or by the context, the powers and authority of my attorney and of every and all substitutes appointed, as hereby provided, shall and may extend over and affect all and any property, rights and interest of mine at any time owned or enjoyed, whether heretofore or hereafter acquired and the term "property" whenever used herein shall be deemed and defined as including cash in possession or on deposit, currency, bullion, stocks of any kind or class, bonds, notes, obligations, rights, warrants, options, mortgage, mortgage certificates, mortgage participations, certificates of indebtedness, certificates of interest, judgments, liens, and all goods, chattels, effects and other property of any kind whether real, personal or mixed, tangible or intangible, and any interest therein.

Marginal headings

4. The marginal headings contained in this instrument are for convenient reference only and shall be given no legal effect.

Presumption from

5. The possession of this instrument by my attorney, or of this instrument and one of sub-appointment by any substitute appointed as hereby provided, shall raise a conclusive presumption that all the powers and authority hereby or therein conferred are, and continue duly vested in my attorney or sub-attorney and that this power of attorney and the instrument of sub-appointment remain unrevoked and unimpaired, and anyone dealing with my attorney or any substitute so appointed shall be fully protected in relying upon that presumption.

Revocation

6. I hereby direct that this power of attorney shall be in full force and effect until it shall be revoked by me, in whole or in part in writing, or until my death, or until I have duly been adjudged an incompetent by a court having and properly exercising jurisdiction, and anyone dealing with my said attorney or any substitute hereunder, may continue to do so in all matters until he receives an actual notice of revocation or partial revocation in writing, actual notice of my death or actual notice that I have been duly adjudged an incompetent by a court having and properly exercising jurisdiction, and I agree for myself, my heirs, next of kin, legal representatives and assigns to protect, indemnify and save harmless anyone in so doing.

Partial Invalidity

7. The determination by any Court of competent jurisdiction that any of the provisions of this Power of Attorney or the powers granted thereunder are invalid shall not affect the validity of any other provision or power which shall be and continue in full force and effect unaffected by such determination.

Entification

8. I hereby ratify and confirm all that my attorney, or any substitute appointed as hereby provided, shall do or cause to be done by virtue hereof, and declare that every such act so done shall have the same effect in all respects as if done by me in person.

Lishility of attorney

9. In order that my attorney shall feel justified in acting for me hereunder in the same way that my attorney would act in relation to my attorney's own affairs, I expressly declare and agree that in no event shall my attorney or any substitute, appointed as hereby provided, be liable to me, or to anyone else for any error of judgment or for any act or omission with respect to my property, affairs and matters hereby confided to my attorney, or by my attorney confided to any substitute, except in case of the willful misconduct of my attorney, or of such a substitute, and no act or omission of any substitute, appointed as hereby provided, shall impose upon my attorney any liability to me or to anyone else.

Severability of authority or death of one attorney 10. The parties herein named and hereby jointly and severally constituted my attorneys-in-fact are herein for convenience referred to as a unit by the term "my attorney." It is my desire and intention that either of those parties, acting separately, and both of them acting jointly, shall have all the rights and powers hereby conferred upon both of them, so that anyone dealing with one or both of the attorneys-in-fact herein named, or with any substitute or substitutes appointed, as hereby provided, by either or both of those attorneys-in-fact, shall be fully protected in all respects the same as if both those attorneys-in-fact had acted jointly, or I had personally acted. Accordingly, the term "my attorney" as herein used, shall be construed in every instance to have reference to both of my attorneys-in-fact herein named, acting jointly, and to either of them, acting separately. The death of either attorney-in-fact herein named shall not affect the rights and powers hereby conferred upon the other herein named. Neither of my attorneys-in-fact herein named shall be liable in any event for any act or omission of the other attorney-in-fact of mine herein named, nor for any act or omission of any substitute appointed by either as hereby authorized.
