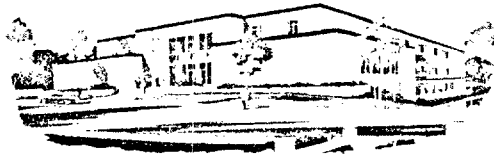

We are in the process of getting up a unit agreement for the development and operation of the West Indian Basin Unit Area, Eddy County, New Mexico, and expect to file with you next week application of Robert N. Enfield for approval of the same.

The proposed unit will cover all of Sections 5, 6, 7, 8, 17, 18 and 20, Township 21 South, Range 23 East, N.M.P.M., containing 4,278.29 acres and consists of 4,118.29 acres of Federal lands, 120 acres of State lands and 40 acres of fee or privately owned lands.

We would appreciate your including this application in your next publication for the Examiner's Hearing which we assume will be held on September 18.

Dear Mr. Nutter:

You have very kindly placed on the docket for the Examiner's Hearing of September 25 the captioned Unit Agreement. We enclose formal application for approval of the agreement.

You will note that when I gave you the information for publication that I advised you that the unit area would comprise 4,278.29 acres of federal, state and fee lands in Township 21 South, Range 23 East, N.M.P.M., and the publication appears accordingly. After the notice was published, the United States Geological Survey determined to eliminate three sections from the designation of the proposed unit area, due to questionable title to leases involved and the failure of Mr. Enfield to obtain commitment of some of the acreage. Consequently, you will note from the application that the unit area has been reduced to four sections, or 2561.28 acres. We do not believe that the notice is defective on this account and would like to go ahead with the hearing on the basis of the enclosed application.
