ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 23, 1965, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

MOW, on this 3rd day of December, 1965, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Sunray DX Oil Company, seeks permission to institute a waterflood project in the Grayburg-Jackson and Square Lake Pools by the injection of water into the Metex some of the Grayburg formation through four injection wells in Sections 14 and 15, Township 17 South, Range 29 East, HMPM, Eddy County, New Mexico.
- (3) That the wells in the project area are in an advanced state of depletion and should properly be classified as "stripper" wells.
- (4) That the proposed waterflood project should result in the recovery of otherwise unrecoverable oil, thereby preventing waste.
- (5) That the subject application should be approved and the project should be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.

IT IS THEREFORE ORDERED:

(1) That the applicant, Sunray DX Oil Company, is hereby authorized to institute a waterflood project in the Grayburg-Jackson and Square Lake Pools by the injection of water into the Metex zone of the Grayburg formation through the following-described wells in Township 17 South, Range 29 East, MMPM, Eddy County, New Mexico:

Square Lake Pool

Sunray DX Dodd B Well No. 9, Unit H of Section 15

Gravburg-Jackson Pool

Sunray DX Dodd A Well No. 19, Unit J of Section 15 Sunray DX Dodd A Well No. 13, Unit P of Section 15 Sunray DX Dodd A Well No. 20, Unit L of Section 14

- (2) That the subject waterflood project is hereby designated the SDX Metex Waterflood Project and shall be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.
- (3) That monthly progress reports of the waterflood project herein authorized shall be submitted to the Commission in accordance with Rules 704 and 1120 of the Commission Rules and Regulations.
- (4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
