



As per your telephone conversation with Pete Martinez on this date, enclosed is an Instruction Sheet for Filing an Oil and Gas Lease, Surface Improvement Damage Bond. Our records reflect that the current Unit Operator of the above referenced Unit is Penroc Oil Corporation, P.O. Box 5970, Hobbs, New Mexico 88240.

Section 8 of the Northeast Square Lake Premier Unit Agreement specifies that whenever the Unit Operator shall tender its resignation as Unit Operator, the Working Interest Owners shall, by affirmative vote of at least 75% of the Voting Interests, select a successor Unit Operator.

Our records do not show that Penroc Oil Corporation has resigned as Unit Operator. Please submit a letter of resignation of Unit Operator from Penroc Oil Corporation and a designation of Evergreen Resources Inc. as the new Unit Operator.
