ORDER OF THE COMUSSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 5, 1966, at Santa Fe, New Mexico, before Examiner Daniel S. Mutter.

MCW, on this 13th day of January, 1966, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises.

ZIMPE:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, General American Oil Company of Texas, seeks permission to expand its waterflood project in the Grayburg-Jackson Pool, authorized by Order Mo. R-2327, by the conversion to water injection, in stages, of from 10 to 13 wells in Sections 23 and 26, Township 17 South, Range 29 East, MMPM, Eddy County, New Mexico.
- (3) That the wells in the project area are in an advanced state of depletion and should properly be classified as "stripper" wells.
- (4) That the proposed expansion of the waterflood project should result in the recovery of otherwise unrecoverable oil, thereby preventing waste.

(5) That the subject application should be approved and the expanded project should be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.

IT IS THEREPORE ORDERED:

(1) That the applicant, General American Oil Company of Texas, is hereby authorised to expand its waterflood project in the Grayburg-Jackson Pool, authorised by Order No. R-2327, by converting to water injection into the Grayburg-Keely zone of the San Andres formation, in stages, the following-described wells in Township 17 South, Range 29 East, HNPH, Eddy County, New Mexico:

- (2) That the subject waterflood project is hereby designated the Grayburg-Keely Cooperative Waterflood Project and shall be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.
- (3) That monthly progress reports of the expanded waterflood project herein authorised shall be submitted to the Commission in

accordance with Rules 704 and 1120 of the Commission Rules and Regulations.

(4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
