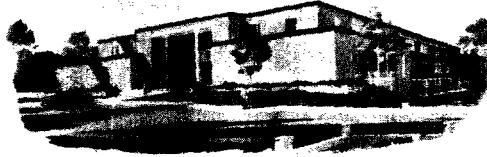

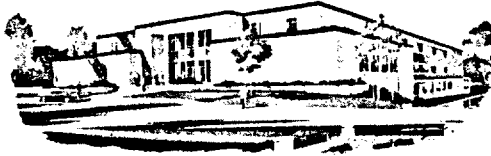

The North White City Unit Agreement is dated March 30, 1968, and was approved by the Commissioner of Public Lands as of May 14, 1968.

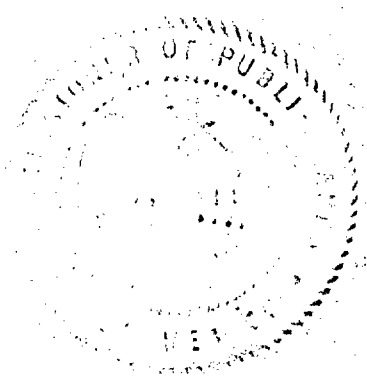
