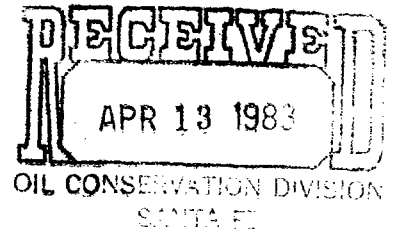

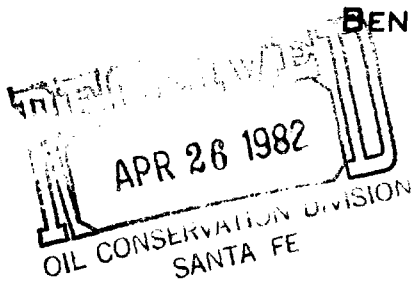
The aforesaid plan calls for the drilling of one well in the basic unit area and one well in the third expansion area.
