

This office is in receipt of your letter of October 13, 1992, advising this office that ARCO Oil & Gas Company has resigned as Unit Operator of the Seven Rivers Queen Unit, Lea County, New Mexico, and Earl R. Bruno Company, has been selected as the successor Unit Operator of said Unit.

Our records reflect that Arco Oil & Gas Company is still the operator of record for this unit. Pursuant to the terms of the Seven Rivers Queen Unit Agreement, any change in unit operators must also be approved by the Commissioner of Public Lands.

Please be advised that this change of unit operator cannot be approved at this time. Our records reflect that Earl R. Bruno Company has not yet filed the required \$20,000 multiple surface improvement damage bond. As soon as the proper bond is received from the Earl R. Bruno Company, we will begin to process your application.

In view of the above, please submit a resignation/designation of successor unit operator to this office for approval. If the change of operator is not filed with and approved by this office, you are operating the Seven Rivers Queen State Unit without authority.



Atlantic Richfield Company (ARCO) is designated operator under that certain Unit and Unit Operating Agreement dated January 1, 1973, which covers the Seven Rivers-Queen Unit Area in Lea County, New Mexico. Pursuant to provisions 7 and 8 of the subject Unit Agreement, the Unit Operator has the right to resign as Operator and a successor Operator shall be selected by an affirmative vote of at least 75% from the working interest owners.

Please be advised that ARCO has sold its interest in the subject unit and hereby resigns as Operator under the referenced Agreements. By an affirmative vote from the working interest owners in excess of 75% (ARCO 57.7118%, Chevron 25.757%), Permian Resources, Inc., d/b/a/ Earl R. Bruno, is allowed to succeed ARCO as Operator (see attached documentation). In addition, Permian Resources, Inc. agrees to accept the duties and responsibilities as Unit Operator, as set forth on the attached letter and Change of Operatorship Forms.
