1 MR. CATANACH: At this time
2 we'll call Case Number 9636.

3 MR. STOVALL: Application of
4 Grand Resources, Inc., for statutory unitization, San Juan
5 County, New Mexico.

6 MR. CATANACH: Are there ap-
7 pearances in this case?

8 MR. CARR: May it please the
9 Examiner, my name is William F. Carr with the law firm
10 Campbell & Black, P. A., of Santa Fe. We represent Grand
11 Resources, Inc.

12 By adjusting the unit boundary
13 and also by negotiating with other interest owners in this
14 area, Grand has been able to reach voluntary agreement for
15 the formation of the Mesa Gallup Unit with all working in-
16 terest owners and has discussed the unit in review with the
17 Navajo Tribe and they are the only royalty interest owner
18 and we believe they will also voluntarily commit their in-
19 terest.

20 For that reason we would move
21 to dismiss Case 9636, which is our application for statu-
22 tory unitization.

23 With your permission, Mr. Exa-
24 miner, we will go forward and present our application for a
25 waterflood project, which is the following case.

1 In the course of presenting
2 that testimony we will also respond to certain questions
3 which are appropriate in that case for a voluntary unit.
4 Today we are filing an application for a voluntary unit.
5 A month from today, or four weeks from today, we will ask
6 that the record in this case be incorporated into that
7 proceeding, so at that time an order can be entered both as
8 to the unit and as to the waterflood project.

9 MR. CATANACH: Any objection
10 to that?

11 MR. STOVALL: Any other ap-
12 pearances first.

13 MR. CATANACH: Any other ap-
14 pearances in this case?

15 MR. KELLAHIN: Mr. Examiner,
16 I'm Tom Kellahin of the Santa Fe law firm of Kellahin, Kel-
17 lahin & Aubrey, appearing today on behalf of Dugan Petro-
18 leum Corporation.

19 We have no objection to Mr.
20 Carr's suggestion.

21 MR. CATANACH: Any other ap-
22 pearances?

23 At Mr. Carr's request Case
24 9636 will be dismissed at this time.

25 (Hearing concluded.)
