AMENDED APPLICATION

TERRA ENERGY LTD, through its undersigned attorneys, hereby makes application for an order approving its South Lone Wolf Unit Agreement and in support of this application would show the Division:

1. That the proposed Unit Agreement consists of ²³⁴⁰~~2120~~ acres, more or less, of Federal, State and Fee lands, situated in Chaves County, New Mexico. The horizontal limits of said unit are described as follows:

Township 13 South, Range 29 East, N.M.P.M.

Section 19: E/2 SE/4
Section 20: S/2
Section 29: All
Section 30: E/2
Section 31: E/2
Section 32: All
Chaves County, New Mexico

2. That the Unit Agreement has been approved by a sufficient percentage of the interest owners within the proposed Unit Area to provide effective control of unit operations.

3. That the Applicant, Terra Energy Ltd, is designated as Unit Operator in said Unit Agreement and all oil and gas in any and all formations is unitized.

4. That the proposed Unit Area covers all, or substantially all, of the geological structures or anomaly involved.

5. That prior to hearing the proposed Unit will be reviewed with the BLM for its approval as an area logically subject to development under a unit plan.


6. That prior to hearing the Unit Agreement will be reviewed with the State Land Office for its approval as to form and content.

7. Said Unit Agreement and the unitized operation and management of the Unit Area will be in the interest of conservation and the prevention of waste, and that it will protect the correlative rights of all parties concerned.

WHEREFORE, TERRA ENERGY LTD, requests that this application be set for hearing before an Examiner of the Oil Conservation Division on June 11, 1992 that notice be given as required by law and the rules of the Division, and that the South Lone Wolf Unit Agreement be approved.
