Gentlemen:

Your application of June 10, 1993, filed with the BLM requests the designation of the Querecho Plains Bone Spring Sand Unit area, embracing 2400 acres, more or less, Lea County, New Mexico, as logically subject to secondary operations under the unitization provisions of the Mineral Leasing Act as amended.

Pursuant to unit plan regulations 43 CFR 3180, the land requested as outlined on your plat marked Exhibit A, Mewbourne Oil Company, Querecho Plains Bone Spring Sand Unit, Lea County, New Mexico, is hereby designated as a logical unit area for the purpose of conducting secondary recovery operations and has been assigned No. NMNM88523X. This designation is valid for a period of one year from the date of this letter.

Waterflooding will be limited to the following interval: That interval underlying the Unit Area commonly known as the Bone Spring Sand, which is described as that certain stratigraphic interval, or its correlative equivalent, encountered between the log depths of 8,328 feet and 8,620 feet in the Mewbourne Oil Company - Federal L No. 4 located in the center NWNE (Proration Unit B) of sec. 23, T. 18 S., R. 32 E., Lea County, New Mexico as shown on the Welex - Laterolog Microguard Log, dated November 28, 1987 and attached hereto as Exhibit D.

Your basis for allocation of unitized substances and your proposed form of unit agreement are acceptable. Corrections that need to be made to the enclosed Exhibits A and B are shown in red.

If conditions are such that further modification of said standard form is deemed necessary, three copies of the proposed modifications with appropriate justification must be submitted to this office for preliminary approval.

In the absence of any type of land requiring special provisions or any objections not now apparent, a duly executed agreement identical with said form, modified as outlined above, will be approved if submitted in approvable status within a reasonable period of time. However, notice is hereby given that the right is reserved to deny approval of any executed agreement submitted which in our opinion, does not have the full commitment of sufficient lands to afford effective control of operations in the unit area.

When the executed agreement is transmitted to the BLM for final approval, include the latest status of all acreage. In preparation of Exhibits "A" and "B", follow closely the format of the sample exhibits attached to the reprint of the aforementioned form. You will also need to submit an initial plan of development.
