Dear Mr. Hoover:

Conoco Inc. has submitted applications and recommendations dated November 19, 1993, requesting approval of revisions to three participating areas (PA) in the Warren Unit, as follows:

- First Revision to the Blinebry-Tubb Waterflood PA (expansion); 1)
- 2) Twenty-fifth Revision to the Blinebry PA (contraction); and
- Fifteenth Revision to the Tubb PA (contraction). 3)

The applications are being handled concurrently as they affect some of the same lands. Data submitted by Conoco in support of these applications includes geological and engineering exhibits, and revised Exhibits A and B.

These applications are hereby approved on this date and are effective subject to the New Mexico Oil Conservation Division's approval of the revisions to the Warren Blinebry-Tubb pool.

The First Revision to the Blinebry-Tubb Waterflood is a proposed expansion to the existing participating area. The following lands are added to the existing PA:

Township 20 South, Range 38 East, Lea County, New Mexico Section 20: SE/4 Section 21: S/2SE, SW/4 Section 28: all Section 29: NE/4, N/2SE

containing 1280.00 acres, more or less.

The following lands are contracted from the Blinebry PA:

Township 20 South, Range 38 East, Lea County, New Mexico Section 20: SE/4 Section 21: SW/4 Section 28: N/2NW, S/2, S/2N/2 Section 29: N/2NE, S/2NE, N/2SE

containing 1120.00 acres, more or less.
