Gentlemen:

I am writing to note our strong objection to Oxy's proposed form of Order on the June 30, 1997 hearing. On July 7, 1997, we received from Mr. Kellahin a fax that indicated that Mr. Carroll asked Oxy and Hartman to prepare and submit a proposed Order concerning the June 30 hearing for consideration by the Division. A copy of Mr. Kellahin's fax is attached. At the June 30 hearing, Mr. Carroll stated that as to the issue of Hartman's right to go nonconsent under Order R-6447 and the Statutory Unitization Act, "I was ready to rule on that prior to Mr. Kellahin's last argument regarding the 'carried'/'carrying' so I'll defer a ruling on that until I receive the follow up memorandums." Obviously, the Division issued no ruling at the June 30 hearing on the nonconsent issue.

Nevertheless, Oxy has submitted a proposed form of Order on the June 30 hearing which incorporates Oxy's argument on the nonconsent issue. We intend to submit a proposed form of Order on the nonconsent issue, if requested, <u>after</u> the Division issues its ruling. If the Division would like a proposed form of Order from Hartman on the nonconsent issue now, please let me know and I will be happy to provide one.
