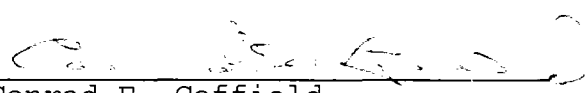
MOTION FOR CONTINUANCE
