Proposal No. 3: An AFE for the current West Lovington Strawn Unit working interest owners to purchase the Snyder "EC" Com No.1 and Snyder "C" No.4 wells operated by Charles B. Gillespie, Jr. for approximately \$158,497 and \$737,273 respectively. Based on oil and plant liquids production from the two wells and savings from reinjected residue gas, payout to the Unit working interest owners should occur in 9.5 months for the Snyder "EC" Com No.1 and in 7.5 months for the Snyder "C" No.4. Gillespie will pay the royalty owner(s) out of these dollar amounts, leaving Gillespie with 116.5 percent payout on the Snyder "EC" Com No.1 and with a 200 percent payout on the Snyder "C" No.4 including all revenue and costs through April 1, 1999. Gillespie, as working interest owner in the West Lovington Strawn Unit, will pay his proportionate share of these acquisition costs.
