2 9:16 a.m.:

3 EXAMINER STOGNER: At this time I'm going to call
4 Case Number 12,549, which is the Application of Yates
5 Petroleum Corporation for approval of a unit agreement, Lea
6 County, New Mexico.

7 Call for appearances.

8 MR. FELDEWERT: Mr. Examiner, Michael Feldewert
9 with the law firm of Campbell, Carr, Berge and Sheridan,
10 appearing on behalf of the Applicant, Yates Petroleum
11 Corporation.

12 EXAMINER STOGNER: Sir, how do you spell your
13 last name? I don't know if I've met you yet.

14 MR. FELDEWERT: It's F, as in Frank, e-l-d-e-w-e-
15 r-t. And I think this is the first time I've appeared
16 before you, Mr. Examiner.

17 EXAMINER STOGNER: How long have you been over
18 with the Campbell, Carr -- ?

19 MR. FELDEWERT: Nine years.

20 EXAMINER STOGNER: And we haven't seen you over
21 here.

22 MR. FELDEWERT: Well, I have recently begun doing
23 some of the administrative work, probably in the last six
24 months.

25 EXAMINER STOGNER: Well, congratulations on --

1 MR. FELDEWERT: Thank you.

2 EXAMINER STOGNER: -- either finally getting over
3 here or nine successful years of avoiding this place.

4 Okay, you don't have any witnesses at this time?

5 MR. FELDEWERT: I do not. I do have one exhibit
6 I would want to introduce at this time, Mr. Examiner. You
7 will recall -- or you will see that this case was heard by
8 Mr. Catanach on December the 7th. It seeks approval of the
9 North Papalotes State Exploratory Unit. At the December
10 7th hearing, Mr. Catanach asked that the matter be
11 continued to allow Yates to discuss the matter with Ocean
12 Energy, who is a working interest owner in the unit area.

13 I have here, which we'd like to introduce as
14 Exhibit 8, a letter, a two-page letter. It's comprised of
15 a facsimile cover sheet to Mr. David Catanach from a Derold
16 Maney with Ocean Energy, dated December 21st. The second
17 page is a December 21st letter from Ocean Energy to Yates.
18 You'll see that with this letter Mr. Maney indicates that
19 Ocean Energy does not oppose the unit agreement and
20 supports the Application.

21 If I may approach, I'll give you a copy of this
22 exhibit.

23 EXAMINER STOGNER: Please.

24 MR. FELDEWERT: And with the introduction, Mr.
25 Examiner, of this Yates Exhibit Number 8, we would ask that

1 the matter be taken under advisement and transferred back
2 to Mr. Catanach for a decision.

3 EXAMINER STOGNER: Okay, anything further in this
4 matter?

5 MR. FELDEWERT: That's all we have.

6 EXAMINER STOGNER: Since there's nothing further
7 in Case Number 12,549, then this matter will be taken under
8 advisement.

9 MR. FELDEWERT: Thank you.

11 9:20 a.m.)
