

1. The proposed Unit Area consists of 2560.00 acres, more or less, of State of New Mexico and fee lands, situated in Lea County, New Mexico. The horizontal limits of said unit are described as follows:

**Township 11 South, Range 34 East, N.M.P.M.**

Sections 14 and 15: All  
Sections 21 and 22: All

2. The Unit Agreement has been approved by a sufficient percentage of the interest owners within the proposed Unit Area to provide effective control of unit operations.

3. The Applicant, Yates Petroleum Corporation, is designated as Unit Operator in said Unit Agreement and all oil and gas in the all formations are unitized.

4. The proposed Unit Area covers all, or substantially all, of the geological structures or anomaly involved.


